Memorandum that Thomas Lyndsey of Lynethwayte cam into this Courte and confessed that he hath setten his interest & title of his mesuage or tenement at Lynethwayte to Thomas Bankes & Robert Crake by Indenture dated the xxvj day of October Anno Elizabeth Regina xxij to have & to hold to them for ten yeres from the first day of May after the date of thes said Indenture with a clause that if the said Thomas Lynesey at Candellmes day after thre yeres be endid do lause the same to his awne use that then he to have the same agayne aells they to enyoie yt thes tenne yeres as apperith in the said Indenture
