William Browne of Giggleswick complains of Richard Burton because he entered a pit belonging to the messuage of the complainant at Cocket Mosse and dug turves in it. Damage 10s we fynde Burton giltie in 4d and in mercy of the court

George Lawson of Giggleswick complains of Richard Brayshey of the same in a plea of trespass because he entered a certain parcel of arable land which George, Earl of Cumberland, had demised to the aforementioned George Lawson. Damage 2s the parties have putt this for ordre and bothe parties in beleve

William Hyne of Giggleswick complains of Adam Preston of the same in a plea of debt of 4s 5d being 3s 4d for a sword, 10d for a pair of *laynes, ring & staple*, and 3d for keys. we fynde Adam Preston giltie to the defendant in 4d which he ... for the laynes and in mercy of the court

William Lindsay of Giggleswick complains of Roger Armitsted junior of the same because, in consideration of 24s paid to him, the defendant conveyed a pasture in Lawmore Close, and pasture rights for one cow and one calf in the Farrmore Close in Giggleswick, to hold for 4 years. Afterwards however he denied him possession. damage 11s the parties .. agred to ordre and the plaintiff in beleve

Adam Preston of Giggleswick complains of William Hyne of Giggleswick in a plea of trespass upon the case because a contract was made between the defendant and a certain Thomas Preston concerning a certain house and 12d given in money. Afterwards litigation was moved in Stanclif wapentake court. we fynde the dfendant giltie - 18d and in mercy of the court

William Armitsted of Rathmell complains of Margaret Armitsted of Giggleswick, widow ... William Armitsted in a plea of debt. 16s 8d This matter putt ordre & bothe parties in beleve

The relict of Thomas Browne of Cockett 8d, Roger Armytsted junior 4d and the relict
of William Armytsted 4d, put their geese in the pasture of Giggleswick against the
ordinance.

Richard Ashe 6d made a trespass in the pasture of Lawmore in Giggleswick with one
horse.

Roger Wilson 4d put two *unsmytt* cows in the pasture of Lawmore against the
ordinance.

Hugh Tailor 4d similarly put three calves there.

Richard Brayshey junior 4d, William Browne 4d, Thomas Stackhouse 4d and William
Wilson 4d made a trespass with their pigs in the fields.

Richard Brayshey junior 12d and Richard Browne 12d did not make their hedges or
fences. Robert Carre 12d similarly.
