Thomas Dockrey of Giggleswick complains of William Hall of Giggleswick in a plea of trespass upon a case concerning debt and occupation of Hall close. 17s 11d

Richard Brayshey of Giggleswick complains of Adam Browne of Giggleswick in a plea of trespass because the defendant entered *a land end* and trampled the crops with his feet and a cart of stones.

Thomas Hyne of Giggleswick complains of Hugh Preston of the same because he took and carried away his *brakans* [bracken] growing at Giggleswick Moor in a place called [?]Cand Banke. 12d

John Armitsted of Giggleswick complains of George Lawson of the same because he cultivated his soil at Saltraynes and took the issues.

Roger Bradley of Underbarrow in Westmorland, through Robert Tailour his attorney, complains of John Ashe of Laikland in a plea of debt of *two duzen of Twilles* or 18s for a horse.
