*Footnotes* 

(1) Juice of buckthorn berries, used to make syrup.

(2) Syrup of buckthorn – juice of buckthorn infused with cinnamon, ginger, nutmegs, boiled to reduce, strained and sugar added. Or boil juice with sugar and add oil of cloves. Purgative, or for weakness due to chronic illness.

(3) Aqua composita – a compound water. Plant mixture steeped in brandy or wine for a few days, then liquid drawn off.

(4) Conserva rosarum rubrarum. A conserve of red rose buds pounded in a mortar and sugar added. Astringent.

(5) Electuarium Mithridatium. Electuary – medicinal substance mixed with honey or syrup. Juices are dissolved and powders added by degrees. This electuary had a wide variety of spices and herbs including cinnamon, ginger, saffron, pepper, fennel, opium etc. mixed with hot honey and an added oil e.g. turpentine, oil of nutmeg etc.

(6) Electuarium Diascordium. Includes leaves of scordium, and other leaves and roots, cinnamon, gum arabic opium. Mixed with Canary wine, boiled to honey thickness. Astringent, narcotic.

(7) Hynd's cordial – not found, unless it is a cordial made from the hindberry, the wild raspberry. Cordial – medicine, food or drink to improve circulation and invigorate.

(8) Saccharum candum album. White sugar candy. Sugar crystallised by a saturated syrup being left in a warm place. For coughs and eyes.

(9) Argentum vivum. This is the classical term for quicksilver (literal translation) = mercury. The symbol is the alchemical symbol for mercury. Used for venereal and skin diseases and general physical imbalances.

(10) Succus Hispanicus. Spanish juice. Liquorice water – soothing.

(11) Emplastrum cephalicum - plaster of (one recipe) pitch, resin, wax, oil of mace. Emplastrum stomachicum – plaster of wax, oils of mace and mint and other ingredients. "& ab" or possibly "ad"? Perhaps Emplastrum adhaesivum – sticking plaster, plaster and rosin melted together.

(12) Species – ingredients.

(13) Syrupus caryophyllorum. Syrup of Clove-July-Flower, clove gillyflower, clove pink. Stand flowers in

boiling water, leave overnight. Strain and add sugar to make a syrup.

(14) Oleum origani. Distilled oil. Bruise, steep for 8 days in spring water with salt and distil.

(15) Crocus optimus. Saffron. Fragrance, dye and a variety of medical uses.

(16) in other drugs ... Chymicall & Galenicall. Chemical drugs, and vegetable remedies (as apart from chemical). Galen was a Greek physician/surgeon/philosopher.

(17) An alembic was a still in two parts; a gourd shaped flask together with the alembic proper which was the cap with a long spout.

(18) Copper stills – copper catalyses undesirable volatile compounds, and is a good conductor of heat.

(19) Phyolls = phials or vials. Gally Potts = gallipots, small glazed earthenware or metal pots.

(20) Physick Books = medical books.

(21) Many items following, to end of column 3, would be used as ingredients of remedies.

(22) Cro: Sope. Probably crown soap, a better-quality soft soap kept in barrels or firkins.

(23) Lamb black, also lam black, lameblack etc. Lamp black, very pure carbon made by burning oil. Widely stocked, cheap, for ink.

(24) Holland's twine. Linen twine of a type imported from Holland.

(25) Cardamom water. Water made of cardamom seeds plus proof spirit plus water, distilled.

(26) Angelica – roots, stems and seeds. Uses include anti-plague. Geneva – spirits usually distilled from grain flavoured with juniper berry juice. Wormwood – bitter plant or plants, used for medicine or to protect clothes/bedding from moths and fleas. Anas (Latin) - means duck, but more likely from "ana", in drug recipes meaning an equal quantity or number of each.

(27) Filleting – heavy binding tape.

(28) Blue indigo - said to be beneficial in jaundice and an astringent.

(29) Sieves, strainers.
