First I give and devise to my son John and his heirs for ever all that my capital messuage and tenement at Knight Stainforth aforesaid with all lands closes pastures hereditaments and appurtenances thereunto belonging and all that water corn mill thereto also belonging (all which I purchased of Mr Samuel Watson deceased) on condition that my said son pay to my dear and loving wife the yearly sum or annuity of £10 over and above all ..... during her natural life at two equal payments in the year: viz. on the first day of May and the 25th day of December the first thereof to be made and begin on such of the said days as shall first happen next after my decease.
