Which jurors for the village of Ingleton say upon their corporal oath that the pain imposed at the last court, for the keeping of water in its correct course, is forfeited by Richard <4d> Gybson, Alexander <4d> Guy, John <4d> Harlyng, the relict <4d> of Thomas <4d> Gybson, Christopher <4d> Denny <and> John <4d> Hyrd in The Moredyk[es]. Therefore they are in the lord's mercy, as appears.

Amercements 4s

Item they say that ~~Thomas~~ <Matthew> <2s> Harlyng <and> Richard <2s> Mayson cut [in error for "kept"?] tenants within their tenure called Byfyrez, contrary to the pain. Therefore they are in the lord's mercy, as appears.

Amercement 12d

Item they say that the pain imposed at the last court upon John <12d> Harlyng for the keeping of Agnes Gybson is forfeited by him. Therefore he is in mercy.

And now a pain is imposed upon the aforementioned John that he ought to remove <the said Agnes> outside this lordship before the feast of the Nativity of Saint John the Baptist next, under a pain of 6s 8d to be forfeited to the lord.

Amercements 12d

Item they say that John <2d> Harlyng, Henry <4d> Fuscroft and his wife, Richard <2d> Wylson of the spring <and Christopher <4d> Denny> abbetted, ~~and~~ consorted with and assisted Matilda Petty, a thief and ill-disposed person, because they bought goods of various tenants in the same place unjustly taken by the same Matilda.
