I am writing to ask your advice about the above chuchyard. This was closed in 1960 and the Parochial Church Council gave notice of this to the Settle Rural District Council and then asked the Parish Council to assume maintenance of the closed churchyard. The Parish Council has looked after the churchyard since, but, as far as I can ascertain, has never recouped the cost of such maintenance from the District Council, though I understand that the Parish Council could do so.

I would be grateful if you could tell me if I am correct in this last item. I am particularly asking at the present time as several of the tombstones in the churchyard have become unsafe and the Parish Council will have to find the cost of their repair. The P.C. intends to trace the owners of the tombstones where possible so that they can attend to the repair of their tombstones individually but in many cases, as some of the tombstones are 200 years old, this will not be possible.

I will welcome any observations you may have on this matter.

Horton-in-Ribblesdale Churchyard

Thank you for your letter dated 3rd May, 1982.

Where a churchyard was closed and an appropriate certificate given to the Rural District Council as described in your letter the effect is two-fold:-

- 1. Responsibility for maintenance of the churchyard passed to the Parish Council.
- 2. The cost of maintenance become a charge on the rates, and although the Parish Council could have claimed reimbursement of the expenses from the Rural District Council the District Council would in turn have recovered those costs from the Parish rate.

Therefore, although you are correct in saying that the cost of maintenance could have been recovered the end result would have been the same - i.e. the Parish rate payers would have paid.

There is a similar situation at Burton-in-Lonsdale where the Parish Council maintains the churchyard but passes any accounts received to the District Councils Financial Officer for payment. The money spent is then recharged to Burton-in-Lonsdale on the Parish rate.

Other Parish Councils in the district also have responsibility for maintenance of burial grounds, some of which are closed and some still in use, and in all cases the costs are met by the Parish.

With Local Government Reorganisation the Local Authorities etc., (Miscellaneous Provisions) Order 1974 contained a provision to the effect that where a Parish was responsible for maintenance of a closed churchyard the responsibility would stay with the Parish.

Although the District Council has the power to contribute towards expenses incurred by any other person in maintaining a burial ground I think it is unlikely that the Council would agree to make a contribution. Nevertheless if the Parish Council wishes to make the application I will submit it to the appropriate committee.

As you are no doubt aware, the Parish Council have taken over the maintenance and repair of the Churchyard.

The only document that I possess relating to this is a letter dated June 5th. I961. This is signed by E Sarginson, Clerk, and states:

"I have to inform you that in accordance with the Local Government Act of 1933, Section 269 (2) which deals with the taking over by the Parish Councils of closed churchyards that the Parish Council do hereby agree to undertake the maintenance of the churchyard, Horton-in-Ribblesdale as from the first day of April 1961, and will maintain it in good order forthwith."

- As a result of comments made by the Bradford Diocesan Registrar it new seems necessary to establish:
 - I. Whether an Order in Council was obtained for the discontinuance of burials in the Churchyard and the necessary certificate was given by the Churchwardens so as to make the Local Authority legally liable for the maintenance of the closed Churchyard.
 - 2. If the Local Authority has taken over the responsibility and upkeep of the Churchyard merely by agreement and not as a result of a closure Order having been obtained, then the position as regards liability would depend on the terms of the agreement made when taking over the responsibility for the upkeep of the Churchyard.

In view of the uncertainty that an Order in Council was obtained I should be most obliged if you will check your records.

It may prove necessary to refer to the Department of the Environment, 2 Marsham Street, London, SWI.

As the Parechial Church Council are meeting on January 17th. your reply will be appreciated.
