[168] Pleas [undated]

John Smythe of Berleweke complains of Richard King and Richard Somerscall his pledge because Richard sold him a stone and a pound of woollen thread, called *15lb of wollen yerne*, in the common market at Settle, asserting and affirming that the yarn was good and merchantable. However it was not.

Henry Foster of Rathmel, tanner, complains of Thomas Blythe of Horton and his goods pledged, that is to say certain footwear in the hands of the bailiff, re debt of 12s by a bill of obligation in which Thomas, with a certain John Feldhouse, bound himself to pay the said 12s.

Richard Somerscall senior complains of Adam Carre because, when Richard put a mare for a period of agistment with a certain Anthony ... [cut off in photocopying] Wilkinson [?]Nappey, the said Adam took it upon himself to ... the same Anthony sufficient agistment ... did not sufficiently ... the same mare.

Richard Somerscall complains of Adam Carre ... cart and carriage ...cultivating the soil ... 39s 11½d.

Richard Somerscall complains of ... trespass at the place aforesaid ...

[169] Thomas Gibson and John ... by/through Peter Clapham gentleman ... re debt of 21s which ... time of his/her death by a bill of obligation ...

Anthony Sheye of Settle complains of ... one piece of ... price 8d which ... 20<sup>th</sup> year of Queen Elizabeth. ... Iveson must pay 5d.

Jenet Kidd of Settle widow of Settle complains of Anthony ... because he, in consideration of ... pasture of one mare at Halyngehead during the time of fog [ie late hay] in Settle ... allowing and warranting for her part, and he did not warrant her, for which reason the mare was amerced at 12d in the lord's court. The defendant denies.

John Siggesweke of [?]Cam complains of John Edlestone alias Clitherowe re debt of 37s 6d by a bill of obligation.
