John Lupton of Settle complains of John Burton of Gawthorpe in Rathmell and Richard Cookeson junior of Settle re debt of 4s for woollen cloth.

William Kidd of Settle complains of Thomas Gregson of the same because he said "*Thow William Kidd ... [edge cut off] take upp my purse and wold not geve me yt agayne*"

William Myddupp of Settle complains of William Lyndsey and Thomas Hall re debt of 18s 6d for two stoness of woollen thread.

Christopher Wood of Dent complains of Thomas Burton of Dent and Edward Hodgson his pledge re debt of 10s on a loan.

Richard Walker of Settle complains of Elizabeth Balderstone widow of the same because she unjustly occupied a garden, parcel of his tenement, to the damage of 20s.

Robert Crabbe of Giggleswick complains of Oliver Watkinson of Settle re debt of 6s 8d for various writings.

William Wytton of Ingleton complains of Robert Procktor and Thomas Bankes his pledge re debt of 8s for three calves.

Elizabeth Balderstone complains of Rawlin Lawson of Settle because he did not allow him to occupy a parcel of land of the complainant's tenement at Callgarth to the damage of 39s 11½d.

Henry Atkinson of Scostropp complains of Robert Corte of Settle re debt of ... [cut off] for a fatted cow.

Margaret Melling of Staynford in the county of Lincoln complains of Adam ... of Settle in a plea of detinue of her filial portion to the value of 35s 4d. The defendant acknowledges 35s. *Ad patriam* concerning the residue.

Richard Lund of Settle complains of Christopher Tatam of Lodge re debt of 4s on a loan to Jane Tatam his wife before their marriage. The defendant denies it.

Richard Lund complains of John Wethirhird of Horton and James Cookeson his pledge re debt of 4s 6d for half a stone of wool.

John Browne of Settle complains of Thomas Newhouse of the same because he unjustly ploughed a parcel of his tenement at Skelbanke.

Thomas Newhouse complains of John Browne because he unjustly ploughed a parcel of his tenement at Skelbanke.

[163] Oliver Watkinson of Settle complains of Richard Lund of the same because he unjustly ploughed a parcel of his tenement at Beate Ridding.

John Watkinson of Lodge complains of James Armytsted of Settle because he left open a parcel of wall at Lodge Close.

John Watkinson complains of Hugh Edlestone and Margaret his wife because Margaret promised to drive away, that is to say, *louke guard in* [ie to protect crops?] but did not do so.

Adam Carre of Capilsyd complains of William Kidd of Settle re debt of 8s.

Richard Somerscalls of Settle complains of Christopher Lawson of Settle because he unjustly obstructed the way at Hallinghead used for manure.

Thomas Blythe of Horton complains of Bartholomew Houlson and Christopher Lawson his pledgere debt of two bushels of oat flour.

Rawlin Lawson of Settle complains of Elizabeth Balderstone widow and Richard Balderstone of the same because the defendants left open *his swyne cote wall* at Settle and their daughter etc [no further details].

Miles Cookson of Settle complains of William Browne of the same because the defendant unjustly occupied his soil at Springe Dalle.

Miles Heaton of Settle complains of Margaret Mytchell widow of Settle because the defendant unjustly occupied a parcel of his tenement, called *his myddingstead*.
