Memorandum that whereas Adam Carre of Granehouse, and John and James Armytsted of Settle, were amerced at the last court for keeping a new hearth by one Richard Somerscalls, being a lame and deaf man, the statute of the realm is to be found within the town of Settle, therefore it is ordered by E. Eltoftes, deputy steward, that hereafter during the natural life of ... Richard, no amercement shall be assessed of the said Adam, John and James for that cause.

And whereas also Robert Corte was amerced for that he had let one John Foster a little end house, it is likewise ordered by the said steward, if the said John do grave any of the lord's moor, or do any offence to the anoyance of neighbours, then amercement for his contempt to be set upon him and not Robert Corte.

John Edlestone complains of John Foster re debt of 2s 8d which he owes him as pledge for James Armitstead.

Geoffrey Sim of Litten complains of John Foster re debt of 24s ... for three hides

John Lupton complains of John alias Jenkin Iveson in a plea of breach of agreement - failed to exchange one real of gold for 10s.

Richard Browne complains of Lawrence Chapman because he owed him 2s 9d for the labour of 3 horses carrying grain from York.

Thomas Lawson complains of Richard Lawson re debt of 2s 6d for rent of a tenement.

Richard Bradley complains of John Rimington and the goods of James Houghton re debt of 12s for the rule of 2 men governed by him.

Richard Bradley complains of John Rimington and the goods of James Houghton re debt of 25s for a horse .

Elizabeth Taitam widow complains of Richard Cookson re debt of 10s for the wages or stipend of William Taitam, the son of the same, serving the same Richard.

[155] Presentments of Settle and Gargrave

Henry Paitson, late of Settle, merchant, 26 September last, at night, in the field of Settle, feloniously took and carried away one horse of Liver Windsor's.

Elizabeth Tatham, late of Settle, spinster, daughter of John Tatham, 4 October last, did *myche*, take, carry away and kill one wether sheep of Hugh Eddleston's at Settle. The skin thereof was found in a dyke, and in a search made by George Somerscalls, the constable of Settle, certain *sherled wool* and pieces of the said wether's flesh were found in John Tatham's house. Elizabeth Tatham confessed.

Margaret Mitchell widow, late wife of Matthew Mitchell of Settle deceased, received part of the wether's flesh from Elizabeth Tatham, found by the searchers at the house; at first denied and afterwards confessed by Elizabeth Tatham.

Matthew Mitchell's wife enticed and allured George Howson, son of the wife of Henry Howson deceased, to convey and bring unto her wool, bread or anything, and she would give him pie crusts and wheat bread etc.

The said late wife of Matthew Mitchell enticed and allured Richard Tatham, son of John Tatham, aged about 12 years, to give her three quarters of white cloth and one little petticoat, and gave him wheat sheaves and pie crusts for the same.

They present the said wife of Matthew Mitchell for a very evil slanderous woman of her tongue amongst her neighbours.

[156] Jane Wilson, late servant to William Watkinson, feloniously broke into his dwelling house and took 7s in money. She has fled and her goods are forfeit.
