Christopher Wilkinson of Nappen was seised of a tenement held of the lord of this manor and has died since the last court. John Wilkinson is his son and heir and is of full age.

Thomas Waddington, free tenant of a tenement in Settle, rent 10s; has died.

Edward Waddington is his son and heir and is of full age.

William Watkinson of Settle has died since the last court [no further details].

Cutting down and carrying away underwood

The ... [cut off in photocopying] of Settle have cut down six little ashes, by the gift of the officer, to repair their malt-kiln of Over Settle, ie *whelpes and lattes*, which were allocated by the steward, therefore nothing in amerement.

Various other ashes cut down for repairs, amerced by the steward.

The same officer has delivered two small ashes to the inhabitants of Nether Settle to repair their malt-kiln, over and above 18 previously delivered by the woodward.

Thomas Barrowes of Settle ... Settle re debt of 6s 2d for wheat and malt.

Thomas Barrowes of Settle complains of Lawrence Chapman of Settle re debt of 2s 8d, ie 20d for malt and 12d on a loan.

John Edlestone of Settle complains of Richard Somerscalls of the same because he unjustly ploughed his soil at Marche in Settle.

James Banks of Feror complains of Elizabeth Tatham, widow, administratrix of the goods of Robert Tatham deceased, re debt of 36s 8d on a bill.

[139] [trespassupon the] case, that is to say, when the same William and John Armytsted stood bound as pledge for a certain Thomas Hill, the aforesaid Robert, upon payment of 50s promised to make good the bill in the hands of the same William, to the intent that William should recover the 50s from Thomas.

John Catterall gent complains of Margaret Wildinge, late of Settle 2 tunics called *a gowne and a peticote* in the hands of the bailiff.

Roger Preston of Ayrton complains of William Smythson of Gargrave "and one horse in the hands of Christopher Lawson, pledge" re debt of 9s 4d as the final payment of 13s for a black mare. Defendant denies. *Per patriam*.

John Lupton of Settle complains of Thomas Bradley of the same re debt of 15d for woollen cloth. Defendant acknowledges but says he paid. *Per patriam*.

John Atkinson of Kirkby complains of Henry Barker of Skipton and R... Corte his pledge re detinue of one cap called *a felt hatte* of price 5s, purchased but not delivered.

Robert Edlestone of Oxsey, through Hugh Edlestone his pledge and attorney, complains of Christian Watkinson widow of Settle re debt of 24s for a bull.

Christopher Browne of Settle complains of Elizabeth Saylbank widow of the same because she put her dunghill on his soil at Hempland.

Christopher Browne of Settle complains of Elizabeth Saylbank widow because she broke his hedge at Hempland.

John alias Jenkin Iveson of Settle complains of Thomas Preston of Skipton and Henry Tenaunt his pledge because he broke his garden at Settle and cut down herbs called *Rosemarye* to the damage of 30s.

Hugh Lawson of Lodge complains of William Lawson of Haulthe and Richard Iveson re debt of 15s which Hugh paid for him to the Constable of Settle.

Thomas Geldert of Settle complains of Christopher Armytsted of the same re debt of 16d for manual labour for two days.

Elizabeth Lawson of Lodge widow complains of William Taylor and John Lupton of Settle re debt of 2s 8d for ploughing.

Robert Corte of Settle complains of Anthony Cookeson of the same re debt of 4s 4d, ie 16d for new shoes, 14d for mending two pairs of shoes, and 18d for food and drink, and 4d for one *bagge* bought from him.

Christian Watkinson of Settle complains of Hugh Edlestone of the same because he broke the woods of the same Christian at Lodge

[132] Miles Cookeson of Settle complains of Adam Carre of the same because he broke his soil at Edlestone Head.

Margaret Mytchell widow complains of Jenet Heton widow of the same re [?detinue] of two [?gold] rings and one handkerchief, lent and not returned.

Jenet Heaton widow of Settle complains of William Hirste and his goods in the hands of Christopher Lawson re debt of 3s 6d owed as pledge for Margaret Mytchell.

Robert Somerscalls complains of John Edlestone alias Clitherowe of Settle re debt of 21s 8d for merchandise.

Miles Cookeson of Settle complains of Thomas Newhouse of the same because he did not make a parcel of hedge between their houses, as a result of which their neighbours' cattle entered the fields and ate the grass.

John Wyndsor of Settle complains of Thomas Lawson of Lodge re debt of 2s for manual labour.

Richard Cookeson of Settle complains of Jenet Kidd widow of the same re debt of 5[?s] which Christopher Kidd the son of the said defendant owes, ie one saddle, 6d on a loan, 6d for labour of one horse.

Richard Lawson of Settle complains of Thomas Lawson of Lodge re debt of 3s 4d for a plough and hay.
