Ayneley head and elsewhere in the fields of Settle for a term of six years, but they did
not occupy the land.

John Lupton of Settle complains of Richard Lawson of Lodge re debt of 2s 6d
for woollen cloth.

Richard Balderstone of Settle complains of Rawlin Lawson of the same because he did not permit him to make a wall between their gardens.

John alias Jenkin WyndSOR of Settle complains of William Lupton, late of Feror, butcher, and Adam Payley and Christopher Lawson his pledges, re debt of 14s 8d for sheep.

Robert Proctor of Cletopp complains of John Edlestone of Settle because he unjustly ... a parcel of turbary at Attermyer.

Miles Hetton of Settle complains of Richard Armytsted and William Foster of the same because he unjustly occupied a parcel of soil called *his dunghill roine* at Settle.

Rawlin Lawson of Settle complains of Roger Swaynson of Staynford and Adam Payley his pledge re debt of 10s.

[123] Thomas Bankes of Giggleswick complains of John Lupton of Settle because he entered a parcel of meadow at Thornebar which Thomas had of the assignment of John Wilkinson for a term as yet unfinished.

Alexander Bankes of Astweke complains of Robert Somerscales of Settle re debt of 26s 8d on a loan.

Henry Knolles of Merebeck complains of John Edlestone of Settle re debt of 2s for the pasture of three cattle.

James Armytsted of Settle senior, constable in the same place, in the name of all the inhabitants, complains of Hugh Lawson of Lodge re detinue of one balista called a ~~gunne~~ *a hargabur*, one *flaxe & Inches*, and one *murryon* which Hugh received from the inhabitants of Settle for the Queen's service, of be redelivered at a day passed, and as yet undelivered.

Robert Heake of Bolland complains of John Waller of Moregarth in Ing... and John Kynge and Christopher Lawson, pledges, re debt of 15s for woollen cloth.

Richard Iveson of Settle complains of John Wilkinson of Gisburne and Richard Somerscalls of Settle his pledge re debt of 25s 5d for an easement called *stable rowme* for three horses each week etc.

Richard Iveson complains of John Wilkinson and Richard Somerscales his pledge re ~~detinue~~ debt of *an wood yron bound pecke* price 12d which he borrowed of the same Richard and has not as yet returned.

Richard Iveson complains of Agnes Payley widow re detinue of a sack which the same Agnes borrowed.

Robert Somerscalls of Settle complains of William Taylor of Settle re debt of 20s for the debt of a certain Alexander Bankes which he promised to pay.

Robert Somerscalls of Settle complains of William Taylor of the same re debt of 20s for the debt of a certain John Heyley.

William Myddopp of Settle complains of Thomas Bradley of the same re debt of 3s ... which William paid for Thomas for certain gelds and taxes.
