Various affrays and assaults
Breaking the common fold
Making a rescue from the fold
Mowing the grass called Bent upon Settle moor without a licence
Keeping sheep upon the Skarre in Settle against the by-law
Keeping animals upon Settle moor in excess of allocation
Trespassing in the fields with beasts
Conveying pasture rights
Robert Somerscale of Newton broke the lord's soil at Wyshawe in Settle and took *flawes* [pieces of turf] from there to Newton for his use [to burn].
Robert Somerscales, being a tenant of the lord, having great timbers delivered to him for the fabric of his barn, tooke some of them to Newton and converted them to his own use.
The same Robert Somerscales encroached upon the lord's waste.
John Lupton of Settle, tenant of Arthur Somerscales, also encroached upon the lord's waste, at Hewytt wood in Settle.

[101] John alias Jenkin Windsor of Settle complains of Edmund Smithson re debt of 3s for manual labour.

John Gaskell of Settle complains of Robert Tompson of Malham and Ann his wife, executors of the will of George Knolles re debt of 4s 6d.

Thomas Atkinson of Kirkby and Christopher Lawson his pledge complain against Richard Browne of Giggleswick and his goods in the hands of Christopher Lawson re debt of 3s fo half a bushel of beans.

Richard Cookeson junior complains of Richard Browne of Giggleswick and his goods in the hands of Christopher Lawson, bailiff, re debt of 6s, 5s for the last payment on a grey horse and 12d for food and drink.

Robert Wyndsor of Settle complains of John Howson of Horton re debt of 26s, ie 21s 6d for 3 stones of wool and 4s 6d for a loan.

Richard Robinson of Long Preston complains of James Knolles of Haltongill because he took and unjustly detained a stag skin.

Anthony Shawe of Settle complains of Margaret Knolles of Funtance fell, widow, re debt of 32s , ie 30s for a cow and 2s on a loan.

John Lupton of Settle complains of Christopher Tatham of Lodge re debt of 3s 11d for white and grey woollen cloth.

John Lupton complains of Robert Corte and Hugh Corte of Settle re debt of 7s for woollen cloth.

Brian Cookeson complains of Thomas Newhous of Settle re debt of 20s on a loan.
