Richard Cookson senior, tenant of a messuage at an annual rent of 29s, [has died], and Richard Cookson his son occupies the premises, but by what warrant they do not know.
The relict of Richard Lunde, tenant of one messuage at an annual rent of 29s, has died since the last court. William Lunde and another son of hers occupy the premises.

William Rendall of Eshe in Preston, Anthony Knolles of the same,
Richard
Hardacar of the same, William Rendall of the upper end of the
town of
Preston, and John Kidd of Langclif, singleman, made trespasses
with
their sheep upon the pasture and moor of Settle.
Thomas Browne senior, James Armytsted junior and Roger Armytsted
put
their cattle in the fields contrary to the by-law.
John Lupton removed the end of the wall of his house at stonegappe in
Settle
near Hewytt Wood contrary to the pain imposed.
Pain imposed that all common *gappes*, viz stonegappe, hudgappe, Tithelayth

and Trage gappe should be pulled down from the feast of All Saints
until
the feast of the Annunciation.
