Jenet Kidd widow broke, uprooted, ploughed and cultivated the soil
and the

lord's waste at Kilneshawe in Settle. Brian Cookeson likewise.
The

borders and boundaries there were altered.
Robert Kidd obstructed the common *gappe* at Hudgapp in Settle,
which the tenants there used to have from time immemorial, and ought
still to have, for driving their beasts to pasture.
Not making fences at Attermyer and elsewhere.
Carrying away an ash without licence.
Carrying away ash branches called *esh sciences*
Carrying away wood called *cartstaves*
John Lupton did not open the way, previously blocked and enclosed, at
Hewit Wood.
Whereas Margaret Mytchell, widow, complained against Miles Heyton
for obstructing the watercourse near her house, and an order was
given to the jurors to view it and make an order; the jurors say that the
overseers of water courses did hold a viewing and did make an order and
assignment.

To this court comes Richard Lawson, son of Thomas Lawson, and shows his
warrant for one messuage, one barn, one garden, two crofts, one close of meadow at
the end of the barn and another called Ayneley, a parcel of meadow called Pynderinge
and 6 acres of arable land in the fields of Settle

Margaret Banks of Giggleswick spinster complains against John Clapham re
debt of 12s.

Miles Heyton complains against Henry Claphamson of Settle because he
entered his land and took dung, and he unjustly occupied the soil in Heyton's croft at
Howsick.

Robert Corte of Settle complains against Elizabeth Iveson, widow, of Settle, re
debt of 3s out of a greater sum for rent of a house taken for one year.

Henry Claphamson of Settle complains against Miles Hetton of the same
because he unjustly occupied the parts of his tenement used for storing dung, and also
cut down the branches of a tree there.

Richard Iveson of Settle complains against Robert Windsor of Settle because
he did not make up a certain ditch and hedge at Settle at the end of his garden which
in lawl he ought to have, by which means draught animals and pigs entered the
complainant's garden and ate his *gresse and passnebs* [grass and parsnips].

Miles Cookeson of Settle, executor of the will of Anthony Cookeson,
complains against Christopher Lawson of the same re debt of 23s 4d.

John Kinge of Settle complains against Henry Claphamson of the same re debt
of 22d for meat bought from the same.

Brian Cookeson of Settle complains against Margaret Mytchell of the same, widow, re debt of ... for rye, wheat, malt and meat.

Christopher Cockett of Giggleswick complains against Christopher Lawson of Settle re debt of 29s for woollen cloth.

Brian Cookeson complains against Christopher Lawson re debt of 23s for oatmeal etc.

John Altham, William Hall, Miles Hetton and Anthony Browne of Settle complain against Katherine Watkinson, widow, of the same, re debt of 2s 9d for the common use of the town of Settle.

[87] The same against Richard Iveson of Settle re debt of 18d as before.

The same against Adam Carre of the same re debt of 12s 1d as before.

The same against Adam Payley re debt of 7s as before.

The same against Henry Claphamson re debt of 2s 9d as before.

The same against Richard Cookeson re debt of 16s as before.

The same against Christopher Lawson re debt of 8s 6d as before.

The same against Richard Kidd re debt of 5s as before.
