Richard Newhouse of Settle complains against Richard Wilson of Giggleswick re debt of 5s upon an account.

Richard Balderstone of Settle complains against John Deny of Ingleton because he did not return nine ewes which Agnes Deny his wife found. He was deprived of their milk.

Anthony Shay of Settle complains against Oliver Windsor because he said *Anthony Shay is a horse stealler*.

Anthony Shay of Settle complains against Henry Claphamson of Settle re debt of 39s 11d for sheep.

Richard Newhous complains against William Catterall esq re debt of 10s upon an account.

Richard Newhous complains against William Catterall esq re debt of one *steale cote* priced 20s borrowed and not redelivered.

Adam Payley of Settle complains against Richard Lawson of Lodge re debt of 20d for beans.

John Lupton of Settle complains against William Hall of the same, administrator of Alice Lund, re debt of 3s 4d which the aforesaid Alice owed on a loan.
