Cumberland, as of his manor of Settle, by military
service and

rent of 6d. Ann Carre and Janet Carre are his daughters
and

heirs. Ann was aged 11 and Janet 8 at their father's
death.

William Edlestone, one moiety of 2 messuages and 100 acres
of land,

meadow, pasture and moor in Lodge in possession, and
the

other moiety in reversion after the death of Christian
Watkinson. Thomazina Edleston is his daughter and
next heir.

Christopher Tatham took 14 sheep as strays, of a certain William
Midleton of

Preston, and agisted them on the pasture of Settle, against the
by-law.

William Hesselden of Brakenbothom complains against Agnes Battersby of Bolton widow re debt of 33s 4d for a stone and a half of wool, for winter agistment of one cow and 21 sheep at Horton, for three quarters of mutton and for half a bushel of barley flour.

William Procter of Kettlebeck complains against Richard Preston of Malham re debt of 7s 8d for agistment and winter care of one cow.

Timothy Tompson complains against William Walshe of Eshton re debt of 2s 4d for white woollen cloth

Henry Tompson complains against Joseph Lupton of Settle because he trampled his grass at Freehill Bank in Giggleswick with his horse, plough and feet.

John Iveson of Settle complains against Christopher Lawson of the same re debt of 20s on a loan.
