Richard Frankland of Meelsynge complains against Martin Knolles of Foxhupp junior re debt of 6s, ie 5s in exchange for a horse and mare and 12d in arrears for another horse.

Richard Whitladale complains against John Swier of Preston re debt of 19s for carriage of three *packes* of wool from Raysbeck to Halifax.

Edward Allan complains against John Smith of Wiglesworth re debt of 21s for a bay mare.

Edward Allan complains against John Smith of Wiglesworth re debt of 21s for a bay mare.

Robert Corte complains against Robert Falthropp of Giggleswick re debt of 5s 7d, ie 16d for a pair of shoes, 4d for sewing a pair of shoes, 15d for sewing a pair of thigh-boots, 20d for 3 pieces of leather, and 12d for labour for one week.

William Geldert of Settle complains against Christopher Lawson of the same re debt of 19d on a loan.

Henry Knolles of Nidderbeck complains against Stephen and Roger Preston of the same because they did not flood and scour the water course at Kilnebanke in Settle, so it was blocked and did not take its usual course, and he was unable to cross.

Robert Altham complains against Brian Cookeson, William Hall, Anthony Browne, William Carre, Thomas Howson and Miles Heton of Settle in a plea of detinue of *a great pan* of price 20s.

Robert Kidd of Settle complains against Thomas Browne of the same because he dug in the ditch of his close at Headdale, in width one foot and in length 5 rods, and indeed upturned the boundary stone fixed between the complainant's aforesaid close and his meadow.

Brian Cookson encroached upon the Lord's waste at Cannott End

bracken.

Henry Tenaunt of Cletopp gent overburdened the pasture on the south
side of

the wall with 4 beasts, in English *fower cattlegates*, not
marked.

Ralph Hodgson and Richard Midhopp likewise. Henry Kendall
similarly with

sheep, in English *a bestgate in sheep*.

Roger Swainson did not put his bill to the by-law men concerning rent
and

beasts before 15 April. He also overburdened the pasture.

William Tailor complains against Agnes Armitsted widow because he, with a
certain William Armitsted her late husband, in her lifetime, demised two parcels of
land in Settle Nether Ynge to the same William for 12 years. Afterwards William died
and Agnes claimed title. William paid her 3s to confirm the lease. However she took
and carried away [not specified what].

Anthony Shey complains against Ann Lawson widow because she took away
his hay lying in stacks on his land at Salt Swillinges in Settle, contrary to the order
made by Henry Tenaunt and George Somerscale.

James Haughton of Rathmell complains against Robert Corte and Hugh Corte
of Settle re debt of 28s in arrears out of a greater sum for processed [*pandaxatus*,
literally "brewed"] leather.

James Haughton complains against Robert Corte and Hugh Corte of Settle re debt of 16s in arrears out of a greater sum for processed [*pandaxatus*] leather.

Adam Carre complains against Ralph Hodgson because he trampled his corn at Sathwait in Settle with his beasts.

[47] Adam Carre complains against Christopher Armitsted because he trampled his corn at Crooked Acres in Settle with his cart and horses and walking feet.

Thomas Procter of Meelsynge complains against Martin Knolles late of Foxhup because in consideration of 38s paid at Settle he promised to deliver one cowe to Thomas. But he did not deliver the cow or return the money.

Hugh Fletcher of Preston, through Margaret Flether his wife his attorney, complains against John Hodgson of Skipton, painter, re debt of 2s 8d for food and drink had from him and his wife. Pledge George Somerscale. The defendant is attached by Christopher Lawson for two pieces of linen and canvas cloth.
