Item the jurors aforesaid present that John Wildman, who was tenant of the lord in the same place of one messuage, with the appurtenances, at an annual rent of 28s, has died since the last court, and has no son or daughter, unless Alicie Wildman his sister etc.

Not repairing fences

Adam Carre and Thomas Howson enclosed the lord's waste at Calbetkraines, but by order of Henry Tenaunt, the lord's officer. And they

found that the soil there was waste, but the jurors say that Adam and Thomas used to mow and harvest grass growing there with scythe and sickle, and they ordered that they should not [?]misuse [word partly cut off] the high ways in the same place etc.

The jurors say that they [?ie Adam and Thomas], at the petition of William Hall, saw a certain parcel of soil in Fayeracre and put divisions and boundaries between the land of the same William, and the land or waste of the said Earl in the same place, and henceforth [they are] to observe and obey the pain previously imposed against the same William.

William Kidd, who is in contempt of court, withdraws without licence, contrary to the proclamation.

[34] ... *Settill now in th'occupac[i]o[n] of Richard Kidd or Agnes Browne was erected & by whome & how much of the soile wherupon it stands weer, before the erection thereof, p[ar]cell of the towne gate of Settill,*

Saieth that shortly after the dissolution of the monastery of Salley in ye countie of Yorke one S[ir] Xpof[er] Kidd al[ia]s Stamford al[ia]s Tailor did buyld or cause the same to be buylded, & had license of the right hon[ou]rable Henrie, then Erle of Cumbreland, to erect & place one paier of Crockes upon the said town gate be... [rest of word cut off] then the [?]myer or waste of the said Erle,

But how much ground of the said town gate was included within the compasse of the said Crockes he Cannot cerenly declare, but referreth himself to the lordes Court Roolles at that tyme wherin he thinketh the quantitie therof is set downe by verdit of 12 men,

Which declaration Adam Paile & Robert Altham do affirme to be true, and Adam Brown & George Som[er]scale do very well remember they weer of that Jurie w[hi]ch did p[re]sent the p[re]misses & the c[er]tentie th[er]of.

John ... complains against James Armitsted senior because he occupied a parcel of land of his

James Armitsted senior complains against John Brown because he broke and ploughed a certain parcel of land in Settle called Hemplands.

William Newby tanner complains against Matthew Atkinson in a plea of debt of 39s 11½d for processed [*pandaxatus*, literally "brewed"] leather.

Miles Cookeson complains against William Hall because he occupied a meadow of his at Hawyng Head in Settle for the space of six years.

Robert Kidd complains against John alias Jenkin Iveson of Settle because he entered a close of his at Crookedales alias Myrydales in Settle and quarried stones called *quarne stones*.

Jane Crake widow, executrix of the will of Robert Crake, through Ann Crake spinster her attorney, complains against Brian Cookeson of Settle in a plea of debt of 20s which he unjustly detains out of monies lent to him by Robert. The defendant says that he faithfully paid Robert in his lifetime and asks that he might wage law four-handed. The aforesaid Brian, with Adam Carre, Adam Pailey, Anthony Brown and Christopher Lawson, is sworn and acquitted.

William Settle of Newton complains against Richard Tompson of Hellifield, linen webster, concerning linen thread undelivered.

[36] ... Lawson and Ann Lawson widow complain against Hugh Lawson junior broke and entered their close called Lodge Loyne in Settle and dug the soil there.

Keeping *two famylies* in one cottage

And they say that Ralph Hodgson and Thomas Geldert keep two households, in English *two famylies*, in one cottage of a rent per annum of 20d, contrary to the form of the statute enacted and provided in respect thereof. Therefore they should pay to the lord of the Leet, for one month, 10s.

Not wearing woollen caps

Christopher Breadshey of Eshton, in open market at Skipton, without any

authority, taking it upon himself to correct measures in the same place,

broke a measure called *half a peck*.

James Knolles has granted and confirmed his message to Richard Brown and Adam Brown.

Thomas King broke the fold.

Richard Bradley overburdened the moor with his beasts.

Richard Bradley and Thomas Newhous kept *ther drift sheepe* outside their walls.

Agnes Watkinson widow had 5 sheep, extending to 2 cattlegates and more, taken as strays upon the pasture and moor, against the by-law. She also harvested and acquired grass in the lord's woods without right.

Hugh Lawson did not mark, in English *did not smott* his sheep put upon the moor on the southern side of the wall.

The same Hugh, and James Armitsted senior, did not make their parts of the fences around Attermier.

Thomas Howson cut down and carried away an ash sapling from the lord's wood in Kirkegate Lone.

Ellen Pudsey spinster complains against Adam Pailey of Settle and Jenet his wife because she delivered to Adam and Jenet, innkeepers at settle, safe custody of clothing made of woollen cloth, called *a safegard of purple Kentishe cloth* of value 39s 11d. However the same Janet has refused to return it.

Christopher Armitsted of Settle complains against Christopher Tatham of Lodge in a plea of debt for 5 bushels of peas.

William Foster of Lauclif complains against John Lupton of Settle because when he was possessed of a certain dung-heap he allowed the defendant to take dung but he has not made it good or paid for the same.

Robert Iveson complains against Richard Pailey and Agnes his wife in a plea of trespass upon the case. Agnes used certain words etc at Settle, in English, *thow art a theeff & thow hast stollen my chee...*

[31] John Lupton complains against Christopher Armitsted because he moved his grass at Stackstead near Howbeck side in Settle

John Brown of Funtan Fell complains against Lionel Frankland of Hallongill that he should yield up one ballista with an arrow instrument called *a cross bowe and a Racke, an arrow bagg & 3 arrowes* which he lent him.
