Oliver Windsor of Settle complains against Robert Altham and John Altham his son because they broke his soil on the south side of his garden at Settle

The same Oliver complains against John Altham because he enclosed his soil on the west side of his garden at Settle, and unjustly occupied it, and obstructed his usual way.

Anthony Foster of Rathmell complains against Ralph Hodgeson and Roger Armitsted of Settle re debt of 10s on a bill.

Robert Windsor of Settle complains of Christopher Tatham of Lodge re debt of 12s 9d for iron and manual labour, in English *smythe work*.
