In the name of god Amen the third day of February in the year of our Lord God 1662 and in the 15th year of the reign of our most gracious sovereign Lord King Charles II of England etc. I Charles Radcliffe of Austwick in the county of York Yeoman being sick of body at present but of good and perfect memory praised be God do make and ordain this to be my last will and Testament revoking all former wills by me made whatsoever. First I commend my soul into the tuition of the Almighty hoping and assuredly trusting through the only merits of Jesus Christ my saviour to be made partaker of the everlasting kingdom of glory. And unto Mary Radcliffe my sister 50 shillings. Item I give unto Elizabeth Garforth Isabel Radcliffe Mary Radcliffe my sisters and unto the above said Rosamund all my linen which I have at Wakefield in the county aforesaid and equally to be divided amongst their four persons. Item I give unto my brother Henry Radcliffe of Clapham 40 shillings and unto Susan his wife 40 shillings. And unto his six children each of them 20 shillings apiece. Item it is my mind that he the above said John Carr my nephew shall be my sole executor he paying and discharging all my debts legacies and funeral expenses within the space of one whole year next after my decease. Also I desire my friends and neighbours William Beecroft and John Backhouse to my supervisors to that intent as they be assistant unto my said executor and to see my will performed.
