Item it is my will that my younger sons be kept at school till they be able to serve apprenticeship. Item it is my will that the seven pounds which is in James Garnettes hands the same shall be accounted in one portion of goods and the same seven pounds with the increase thereof I give to my younger sons. And if either of them die it to remain to the survivor. Also it is my will that my brother Thomas have such bequest as is appointed to him by my father's will and according to the true meaning thereof. The rest of my part of goods not bequeathed my funeral expenses paid I give it wholly unto my two daughters equally between them so always as they shall be ruled by their mother and my supervisors. And if either of them refuse to be guided either in marriage or otherwise as my wife and supervisors shall think meet they to have no part of this my gift (?). And I ordain and appoint Isabell my wife and Richard my son my joint executors of this my last will and testament. To my son John all my messuages, tenements and lands, freehold and leasehold in Settle, he paying out of the same to his mother Margaret £13 per year for life in two equal instalments at the feasts of St Martin the Bishop in winter and May the first. To my son John six beast gates or cattle gates in one pasture called Hensides in the township of Langeliffe county York for all my term of years yet to come.

To my son John all my books and papers.

To my wife one third part of my household goods and £20 to be laid out for her use at the discretion of my daughter Agnes until her first rents are due.

Joint executors -- my two daughters Agnes and Lettice Ellershaw -- all personal estate not otherwise bequeathed to them, they paying to my son John £100 when he shall require it.

My wife Millicent is to have all household goods, husbandry gear and personal estate. After my wife's decease my estate at Giggleswick is to be sold by my daughter Mary - from the money 40 guineas to my son Thomas and the rest to be divided equally between my son Thomas and my daughters Mary and Lettice.

My mind is that the five and 20 shillings free-rents out of William Carr his estate at Paley Green shall not be sold to William Carr or Thomas Carr his son or any person for less than £35.

## WILL of Richard Preston of Giggleswick 1657

#### Borthwick vol. 46 fol. 452

To be buried at my parish church of Giggleswick. Debts and funeral expenses of my whole goods. To Margerie my wife one third part of all movable goods and she to enjoy all that part of my house from the range wall eastward, and the east side of my garden from the east corner of my chamber window to the great thorn in the north side of the said garden; and one third part of my grounds under the Scarr for life; she also to have and enjoy all my grounds at Stangrams and Brackenbarr close for life -- she is to maintain my three youngest children Margaret, Mary and Joseph Preston till they are 21. To my daughter Margaret Brackenbarr close. To my daughter Mary my parcel of ground at Stangrams next to Brackenbarr. To my son Joseph my other parcel of ground line near Stangrams Sike. All the above three legacies at the death of my wife. To my son Michael Preston the above-mentioned east end of my dwelling house and the east part of my garden and my laith or barn next to John Cotes immediately after the death of my wife. If Michael, Margaret, Mary or Joseph die before the age of 18 then their legacies equally between my children born or to be born of the body of my said wife by me.

To Ellen my daughter out of my goods not disposed six pounds if she come within seven years to demand the same in her own person or the same to be equally divided between the Elizabeth and Ann my daughters. To my son Michael 20 nobles towards finding him with clothes during his apprenticeship. To my son Joseph 20 nobles. To my son John seven pounds. To my son Richard five marks. To my daughter Frances four pounds. To my daughter Mary five pounds. To my daughters Elizabeth and Anne four great pewter dublers which were their mother's. To Marjorie my wife a square table, a desk and a counter which were her father's. My wife Marjorie and my son William to be joint executors and I do wish them to bestow my funeral expenses at my son Wilson's (?) his mark
