In the name of God Amen the fourth day of Januarie in the yere of oure lord god one thowsand fyve hundrethe seventie seven & in the twentie yere of the Raigne of oure Soveraigne ladie Elizabeth by the grace of god quene of Englande france & Irelande defender of the faythe &c I Richarde moone of longe preston in Craven in the countie of yorke yoman beinge in good & perfct mynde and Remembrance thankes be to almightie god maikes & declayrethe this my last will & testament in manner & forme followinge firste I bequeath & commende my soule to god almightie my maiker and Redemer in whose holie presance with & amonges his blessed mother Saint Mary & all other the blesste company of heaven I truste by & thorowe the merrites of the passion of our Saviour Jesus christe that my place is prepared to be their a partaker of the joyes due to all suche as god sayethe elected & chosen And my bodie I will be buried within the parish churche yerde of preston aforesaid, that is to say on the Southe side nighe unto the churche wheras the Crosse stande Also I will that such obsequines and funerall ceremonies be done and celebrate at a monthe day of my buriall as the lawe of the churche will permitte & suffer and that my body shalbe honestely brought to the grave as to my executor shalbe thoughte good & conveniente for my degree and staitt Also I will give & bequeath unto my son Edmund moone one pasture close with a dove cote standinge & beynge in the same close and xviii acres of arable lande be it more or lesse in Seclethorpe in the parish of loutheborrowe in the countie of lecester & thre acres of medowe lynge & beinge in the northe medowes of loutheborrowe aforesaid at the Swannes neste together with one oxgangee of lande in lougheborrowe aforesaid & all & singular there closes landes medowes leasures pastures fedinges woddes, underwoddes rentes reversions & commons & all other my heredtitamentes whatsoever with all liberties easementes comodities profittes & appurtainances to the sayme or to any parte or paecell therof in anywise appurtaininge or belonginge set lyinge or beinge in Seclethorpe or loutheborrowe aforesaid or either of them To have and to holde the said pasture, close, dovecote, & all other my said landes, Tenementes & hereditamentes with appurtainances before expressed unto the said Edmunde moone to his heirs and assignes for ever to the onlie use & behofe of the same Edmunde his heires and assignes for ever. Also I will give and bequeath unto the said Edmunde my sonne my chiste one table or borde called a counter one almerie with all stone troughes & Timber would lyinge in & aboute the house wherin I nowe dwell & yet not occupied to thintente onely that he the said Edmunde shall have the use & occupacon thereof duringe his naturall lyfe & so deliver them over againe unto his sonne & heir or other his heire as heirlomes & upon the Same condicon Also I will, give & bequeath unto Thomas moone Second sone of my said sone Edmunde Xli And also one Cowe also I will, give & bequeath unto William moone the youngest Sonne of the said Edmunde Xli Also I give & bequeath unto Isabell moone the wyfe of Richarde moone one Cowe Also I give and bequeath unto George moone fyve shillings Also I give & bequeath unto Robert littlewodd Vs Also whereas John pateson of Preston aforesaid is at this point indebted & dothe owe unto me the Summe of XXVIs VIIId of lawfull English money nowe my mynde & will is that yf the said John pateson his executors or assignes or any of them well & trulie contente & pay or cause to be paid unto my executor or his assignes the said XXVIs VIIId at suche tymes & days wherein it is due or oughte to be paid at withoute frawe or further deley Then my mynde & will is that my executor or his assignes shall upon the recepte of the laste parte of the said XXVIs VIIId geve unto the said John pateson to his executors or assignes the Sume of iiis iiiid of like money Also I geve and bequeath unto Alice Readman my sister iiis iiiid Also I will geve & bequeath unto Richarde mone Sone & heir apparente of the said Edmunde moone one younge Colte Stagge which was under my bay mare Also I geve & bequeath unto every one of my godchilder whom I am godfather unto yf they come for it iiiid The reste & reversion of all my goodes unbequeathed my debtes legacies & funerall expences discharged I geve and bequeath unto the said Edmunde moone whom I make executor of this my laste will & testamente to execute doe & discharge all thinges necessarie to the healthe of my soule & discharge of my dutie to the worlde accordingelie as to hym shallbe thoughte good & Convenente Theis being witnessses Anthony Knowles Anthony holgate Thomas Clarke & Rowlande Crawshay
