HENRY LEYLAND of Malham. County of York.

IN THE NAME OF GOD. AMEN ye twenty sixth day of february in the year of our Lord God 1673, I Henry Leyland of Malham in ye County of Yorke Husbandman being sick in body but sound and pfect memory praised by God for ye same, I see make this my last will and test-ant in manner & forme following, first I comitt and comend my soul to Almighty god, my maker hopeinge through ye merritts of Jesus Xt my Saviour & Redeemer to have everlasting life, & I comitt & comend my body to ye earth to be buryed in ye Church-yard of Kirkby in Malhamdale at ye discretion of my ffriende and executor hereafter nam'd, As my temperall estate I dispose thereof as followeth, first I will yt my debts & funerall expenses be paid & discharged, Itm. I give & bequeath unto Agnes Leyland my wife three pts of my lands & leases in Malham afforesd for tearme of her Life & all ye insight and bedding within my house to be att ye disposing of my sd wife Agnes exceptinge one Counter-table one Ambrie one brass pot, one Great brandith Pan two Arkes, fower Corne Sacks, & two lesser sacks wch I give unto my Sonne Willm Leyland upon conditon yt, he buy one new chest to be att ye disposing of my wife as afforesd, Item I give unto my wife Agnes one Cow, Item I give unto my daughter Alice Leyland twenty six pounds to be pd unto her at ye end of two years after my decease & upon paymt of ye same the said Alice giving a lawfull discharge unto my Executor hereafter-nam'd or else ye last mentioned bequest to be voyd, Itm I give unto my daughter Jennet Layland twenty six pounds to be pd unto her att ye end of two whole years next after she accomplish ye Age of twenty one years and upon paymt of & same the sd Jennet giving a Lawfull discharge unto my Executor hereafter-named, or else the last mentioned bequest by voyd, Item I give unto my daughter Agnes Leyland twenty six pounds to be pd unto her at ye end of two whole yuars next after she accomplish ye age of twenty one years & upon payment of ye same, ye sd Agnes giving a lawfull discharge unto my Executor hereafter-named or else ye a last mentioned bequest to be voyd, Item I give unto my grandchilde Elizabeth Bradley ten shilling to be pd unto her father Henry Bradley at Midsummer come twelvemonth after my decease he giving a discharge unto my Executor hereafter-named, Item all ye my Lands, Leases, Husbandrie-gears, .....ick, goods, psnall estate, goods & chattells whatsoever I give to my son William Leyland upon condition that he pay my debts & Legacies, & I doe make my sonne Willm Leyland full & sole executor of this my present last will & test.... .... doe hereby revoke, dissanull & make voyd all former wills & testants by me heretofore made, In witness whereof I Henry Leyland to this my last will & Testant have put to my hand and seall ye day & year first above written .....ed, Signed, & acknowledged in ye sight & presence of us Richard Kitchinge, Thomas Atkinson, Thomas Akins, Henry Bradley.
