Commentary

This will was found in the West Yorkshire Archives because in 1541 Clapham was in the Diocese of York. The Diocese of York was transferred in 1541 by Henry VIII to the new Diocese of Chester. The wrapper found in the Lancashire Record Office must have been wrongly placed here at some time or the will transferred to the WYAS.

The Act of 1529 regulated 'the taking of mortuaries, or demanding, receiving or claiming of the same' but those testators with goods valued at less than £30 were exempt. The will expresses Catholic sentiments with its reference to 'our blessed lady ... celestial company of heaven' despite being written in 1541 at the latter end of the reign of Henry VIII and after the Dissolution of the monasteries.

In the Clergy of the Church of England Database William Bank and Christopher Howden are recorded as being in Clapham in 1554 but of unknown office. Christopher Howden is in this will noted as vicar of Clapham which is a new piece of information for this date (resigned 1574). The title 'sir' was commonly accorded to priests as a sign of respect.
