## MANSION HOUSE FUND.

At an influential Meeting of Citizens of London, held at the Mansion House, on March 26th the following Resolutions were carried unanimously :—

1. Moved by The Right Hon. Arthur J. Balfour, M.P., Seconded by the Right Hon. Sir William Harcourt, M.P., and Supported by the Right Hon. Joseph Chamberlain, M.P. :—

“That, in the opinion of this Meeting of Citizens of London, a National Monument should be erected to the memory of the late beloved Queen Victoria on the site in front of Buckingham Palace, approved by His Majesty the King.”

2. Moved by the Governor of the Bank of England, Seconded by the Chairman of the Stock Exchange, and Supported by Alderman Sir Whittaker Ellis, Bart. :—

“That this Meeting heartily pledges itself to support the Fund now being raised by the Lord Mayor at the Mansion House in furtherance of this mark of the devotion of the Empire to the late Queen’s Memory, and earnestly commends the proposal to the sympathetic munificence of the community, not only in the City of London, but in the counties, cities and towns of the United Kingdom, and throughout His Majesty’s possessions.”

To the Parochial Electors of the Township of HORTON-IN-RIBBLESDALE.

---

LADIES AND GENTLEMEN,

Acceding to repeated requests that I should allow myself to become a candidate for the Settle Rural District Council, I have pleasure in placing my services at your disposal. As a large property-owner, ratepayer, and resident in your midst, our interests are identical, and I therefore feel it my duty to take an interest in the welfare of the Parish. It would, perhaps, be well to state that I was educated at Wellington College, subsequently proceeding to Cambridge, and in due course I obtained my B.A. Degree in Law. Leaving the University, I entered the Estate Office of a very large Land and Colliery Owner, where I was thoroughly grounded in all clerical work and gained sound practical knowledge in building, surveying, afforestation, &c.

**HIGHWAYS.** The growing cost of the Highways is a matter which deserves most serious and earnest attention. There are no Main Highways in the Township, and of the 30 miles, about 8 are District Roads and are repairable by the Settle Authority. For the five years ending September last, a sum of £2,332 has been levied in Horton for Highway purposes alone, and from this amount the Parish has reaped but little benefit; less than 25 per cent. finding its way back. With respect to the *ratione tenuræ* roads the District Council are willing to take them over on much easier terms than heretofore, and, if elected, I will use my best endeavours to alter the existing state of affairs, which have obtained too long.

**WATER SUPPLY.** The present adequate water supply is a valuable asset to the Parish, and is absolutely essential to the well-being of its inhabitants. I readily recognise that the charges are now somewhat high, but with an increased consumption the cost can be lowered, and I would do my utmost to effect such change at the first available opportunity. The special rates levied in the Parish during the past few years have pressed unjustly on the outlying ratepayers. In any future special rates I would, if at all possible, endeavour to obtain a circumscribed area.

# TOM LORD - INDEPENDENT

### WHY INDEPENDENT?

Firstly I would point out that I am an Independent candidate by choice, having refused offers from both political parties to stand as a candidate in the forthcoming local government elections. The idea that the days of the independent councillor are numbered is a myth perpetuated by political parties who are using the local elections as a lever to bolster their sagging fortunes as either government or opposition parties in Westminster. Remember, Councils do not make laws, they merely carry out statutory duties. Politics have no part to play.

A councillor needs two attributes—common sense and a conscience. A decision is either right or wrong for the district and the people you represent. No party whip should be allowed to alter that decision.

### LOCAL PROBLEMS

Good planning is the key to nearly every problem facing any Council and at local level I quote Settle as an example. By forethought and buying land against local political opposition the Creamery is to expand, the paper mill is expanding, a new burling and mending firm is coming to the town and numerous local firms are thus being allowed to expand. Because land has been made available there will be new schools an old folks' home, a new health centre, a group flatlet scheme and new car parks. At last, after years of stagnation, Settle is moving again.

Unfortunately half our district is outside local planning influence. It is under the authority of the National Parks Committee who are a law unto themselves. Part of the membership of the Committee is drawn from the County Council and the rest depends upon the government of the day. The Parks Committee have their priorities wrong! They are spending £70,000 of your money to provide a picnic site at Ribbleshead yet the W.R.C.C. refused a similar venture at Tosside which would have provided the same facilities for virtually nothing. They are spending £40,000 on an Information Centre at Malham to add to the problem of traffic congestion in Malhamdale. Thousands of pounds are frittered away.

Meanwhile our local Council is denied the right by the W.R.C.C. to borrow money to give villages like Rathmell and Arncliffe a sewerage system. Much as we all welcome tourism the first priority in the Dales must be to safeguard the livelihood of the people who work and live here. The view of Penyghent or Malham does little for a man who has lost his job through a bad planning decision.

Our district is rich in minerals—copper, lead, zinc, calamine, limestone have all been mined at one time or another. This is a quarrying area and our local economy depends on limestone. By all means apply stringent planning controls, but to call for closures seems lunacy. The wagons of which we complain are driven mainly by our local men. It is not the drivers' fault they still have to rumble through our villages and along our lanes. Successive County Councils have done little or nothing to bypass our villages. Planning and bypasses are the answer, not the closure of quarries or the banning of wagons.

Finally, as a local man with eight years experience of Council work and procedure, a past chairman of Settle Parish Council, present chairman of Settle Rural District Council, I feel I have the experience and local knowledge to represent this division.

**Whereas** the several Commons and Moors within the Manor of ~~Newby~~, called ~~Burn Moor, Newby Moor, and Ingleborough~~, have of late Years been much Injured by various kinds of Unlawful Trespasses; especially by persons Paring, Digging and Carrying Away Turf and Flaws from ~~Burn Moor and Ingleborough~~, not having any Right of Common thereon; and also by other persons Graving Prickings and Topsods and Destroying the Herbage ~~not only on Burn Moor and Ingleborough~~, but also on ~~Newby Moor~~, and by Gathering the Dungs of Cattle on ~~Newby Moor~~, and Selling the same in defiance of the several Fines and Penalties imposed and Set by Jurors at the Courts held for the said Manor.

**Notice is therefore hereby Given,**

That if any person or persons shall at any time hereafter be discovered committing any of the above Trespasses, or any other wilful Trespass, upon any of the said Commons or Moors, the Fines and Penalties imposed at the Courts of the said Manor, will be levied upon all offenders, or they will be otherwise Prosecuted with the utmost rigour of the Law without further Notice.

II. THAT Mr. *Henry Hook* the Agent of the Vendor shall be at liberty if he think fit, to make one bidding in the course of the sale, on the Vendor's behalf.

III. That the highest bidder shall be the Buyer; and if any dispute arise respecting the biddings, or if the highest bidder refuse or decline immediately to comply with these conditions, in every respect, the Vendor shall be at liberty if *he* think fit, to resort to the last or any other preceding undisputed bidding, which shall be binding upon the respective bidders thereof, and the Vendor may proceed thereon as if no advance had been made upon the same or at *his* option enforce the sale against the bidder liable to be considered the Purchaser.
