Memorandum that Thomas Carre of Rathmell came into this Courte and shoed a deed made from the lord bearinge date the 28 day of October in the 27 yere of his Majesties Reigne wherby the lord hath grated unto the said Thomas his heires and assignes forever in fee ferme all that his mesuage or tenemente with thappurtenances in Rathmell then in thoccupacon of the said Thomas or his assignes To have & to hold to the said Thomas his heires & assignes forever ~~of~~ in fee Ferme off the Chief lordes of the Fee by service therof besed dew accustomed and payinge unto the said lord his heires or assignes as a Fee ferme the pane of 17s of lawfull money of England yerely at the feaste of St Martin in Winter & Pentecost ... *Latin Text* ...

Thomas Newhous, William Brown, Robert Kellett 3s 4d and Adam Browne did not make their exterior fences at ~~Cockett~~ Spring Cragge in Giggleswick.

Wife of William Sealby 6d cut down and carried away the lord's underwood.

A pain is imposed that each tenant should repair and maintain their part of the lord's *catibuli* [*can't find a translation of this word - Brooke Westcott*] at all times under a pain, for each default upon warning given by the by-law-men, of 12d.

Robert Crake ought to have a descent of *le banke* in Byrkland Fore for his carriage without his soil at L... Acre Dales on the western side of *le Ynge Dike* in *le Ynges* etc.

The jurors impose a pain that William Rome should cut down a fence at Bracanber, by which he has enclosed a normal route, before St John the Baptist next, under a penalty of 3s 4d.

Thomas Brayshey of Giggleswick complains of William Roome of Giggleswick because he enclosed a parcel of land at Ynges in Giggleswick and took the profits. Damage 12d

Robert Carre of Lancliffe pledge for Henry Tompson complains James Foster of Giggleswick in a plea of debt. 16s 8d

Richard Browne of Giggleswick, tanner, complains of Thomas Burton of the same because the defendant, without any reasonable cause, [?failed to] respond to the same complainant in court at Gisburne on two separate occasions, upon which the aforesaid complainant appeared and was unable to pursue his case, whereupon he claims costs. 4d

Richard Browne complains of Thomas Burton because he trampled his crops at Hungerholme in Giggleswick. damage 10s 4d

Christopher Cockett of Giggleswick complains of Thomas White, late of Astweke, and his goods, that is to say, a coverlet and 2 sheets in the hands of Thomas Bankes arrested by the bailiff, in a plea of debt of 5s which he owes him for a loan.

John Kidd of Lancliff pledge for Christopher Cockett complains of Roger Wilson of Giggleswick in a plea of debt 13s 8d which he owes him for sheep bought.

Thomas Foster of Giggleswick complains of Thomas Brayshey and Richard Brayshey

Thomas Burton complains of Richard Browne of Giggleswick, tanner, in a plea of debt of 5s because he carried marl from Meabbank to Rathmell. The Jurye do fynde ... wherof they do fynde 21d payde 3s ...
