Item they say and present that the lord's grain mill has too light an upper stone and seek that it be repaired. Also the measures of tolls, in English *mowlter dishes*, are too big, and other measures called *peckes & mesures* are unsealed. Seals are allocated. John Brayshey, Thomas Stackhouse and Thomas Newhouse have withdrawn their grain from the lord's mill without cause or licence. Each fined 3s 4d. William Browne similarly. Fine 20d.

Anthony Browne and Miles Cookeson Hetton of Settle, collector(s) of monies for the benefit and common use of the town of Settle, both for themselves and for all the other inhabitants of the town, complain of John Lupton of Settle in a plea of debt of 2s for the maintenance of the commons and moor of Settle.

John Tooller of Mawater House, for 4d pledged in the hands of Bankes, complains of Richard Burton of Giggleswick in a plea of debt of 20s in money and a measure of barley or oat flour to the value of 8s which he promised to pay and deliver to the complainant as marriage goods with Agnes his wife, sister of the defendant

Robert Somerscales, through Arthur Somerscales his attorney, complains of Richard Browne of Giggleswick in a plea of debt of 4s.
