plans, but we were in a very despondent state, and I believe that nothing but a sense of duty would have induced us to try." There was, however, no real ground for despondency. There was room in the little town for such work, and the time was ripe for the attempt. Circulars were printed, and nearly every house was visited. On all hands the three young men met with sympathy and encouragement.

The class was commenced with thirty-three scholars; on the second Sunday there were forty-nine, nearly half of whom were married men; and before the end of the first month sixty scholars were enrolled. In the thirty-fourth Annual Report it is stated that since the formation of the classes in 1860, 2471 scholars have been admitted. This is certainly a very remarkable record, considering the small population of the town.

When the classes were formed it was found that a considerable percentage of the adults were not able to read or write; and such instruction was regularly given, whilst the higher purposes of the classes were kept steadily in view. The Elementary Education Act has now changed all this; but in the earlier years of the classes many men, to whom books had been a sealed treasure, had the way to the pleasures of reading opened for them by their attendance at this School.

Perhaps the classes reached their highest point of usefulness between the years 1868 and 1873,—the time of the construction of the Settle and Carlisle Railway. There was then a large influx of workers, who became temporarily resident in the town; and

many of these, to their evident good, made use of the opportunities which the classes afforded them.

Of the three young men who were the founders of the classes the first lived only long enough to see the work well begun; the second died in 1873; the third was for upwards of thirty years the central stay and the head teacher of the School. In 1893 Mr. Brockbank removed from Settle; but the classes are still being carried on with spirit and energy. Altogether the history of the Settle Adult School is the record of good aims well realized, and of good work well done.

Temperance Society. Settle was one of the places in which the principles of Temperance, when first advocated by Joseph Livesey, took quick and sure hold. Joseph Livesey himself looked upon the Settle society as one of the finest first-fruits of his work. The society was founded on February 3rd, 1834.* The report for 1837 gives the number of members at 220. In 1838 the number had increased to 350. An idea may be formed as to the vigour and activity of the society from the fact, as stated in the report, that in that one year forty public meetings had been held, and five thousand periodicals and tracts distributed. The services of the best-known Temperance advocates of that day were secured, and nowhere did those men find their speeches more eagerly listened to, their arguments more thoroughly grasped, their seed sown in a more fruitful field. There also sprang up a band

STATUTES

I. THAT this Society be denominated the SETTLE AUXILIARY TEMPERANCE SOCIETY, and shall consist of such persons as shall sign the following declaration or pledge,—“We agree to abstain from Spirituous Liquors, except for medicinal purposes, and to discountenance the causes and practice of intemperance.”

II. of local advocates who were full of zeal and enthusiasm; whose speech was racy of the soil; whose eloquence—though it might sometimes "lack finish"—was genuine and effective. These men "missioned" the villages, and did a noble work. When the society celebrated its tenth anniversary it was able to report a membership of 420, or including the branch societies of Long Preston and Wigglesworth, of 679. The Temperance cause at Settle is now in a languid and languishing state. Improved methods have been tried, but they have "improved" away the old fire and force. Settle now lags behind, but it should not be forgotten that, considering its size, it once stood almost pre-eminent in Temperance work.

The Settle. Another fact which counts up well to the credit and honour of Settle is its support of the National Lifeboat Institution, and its purchase of two new Lifeboats for that Society. The credit was due in the first instance and in largest measure to the late Mr. Christopher Brown, the Secretary of the Settle Branch, who was also well aided by Mr. Joseph Birkbeck. The splendid results that were gained during the time of Mr. Brown's Secretariat show how much one man, of purpose and of push, whose mind is bent upon one end, may do. The Settle Branch was founded in 1862, and between that date and 1875 it had raised towards this noble object no less sum than £3370. Where could we find another small rural town of which it could be said that it had done so much? On April 14th, 1868, the first of the two Settle Boats was presented to the Society. The day was one of general holiday. The

Boat was drawn, amidst manifestations of delight, from the Giggleswick Station to the Market place, where there was a vast crowd. The Boat was christened by Miss Stansfeld, and was named the "Christopher Brown;" and was presented to the Society by Mr. Walter Morrison, at that time M.P. for Plymouth. The "Christopher Brown" was stationed at Penmon, on the coast of Anglesea; and in its first year was the means of saving from destruction the crews of two distressed ships.

On May 26th, 1875, Settle was again, and for a like reason, in bright holiday garb. A second Life-boat had been purchased, and was to be formally presented to the National Institution. There was again an imposing demonstration, and one of the most interesting features in it was the procession of the children of the seven Sunday-schools, each of whom wore a large medal that had been struck in commemoration of the gift of the two Boats. This second Boat was named by Mrs. R. Ingleby the "Ellen and Margaret, of Settle." The day witnessed another practical result. Mr. Christie pleaded for an endowment-fund for the two Lifeboats, and towards this the warm-hearted Secretary made a gift of £500. The record of what has been thus done locally on behalf of this noble institution is a chapter in the history of Settle which its people may read with a warm sense of gratitude and with some excusable pride.

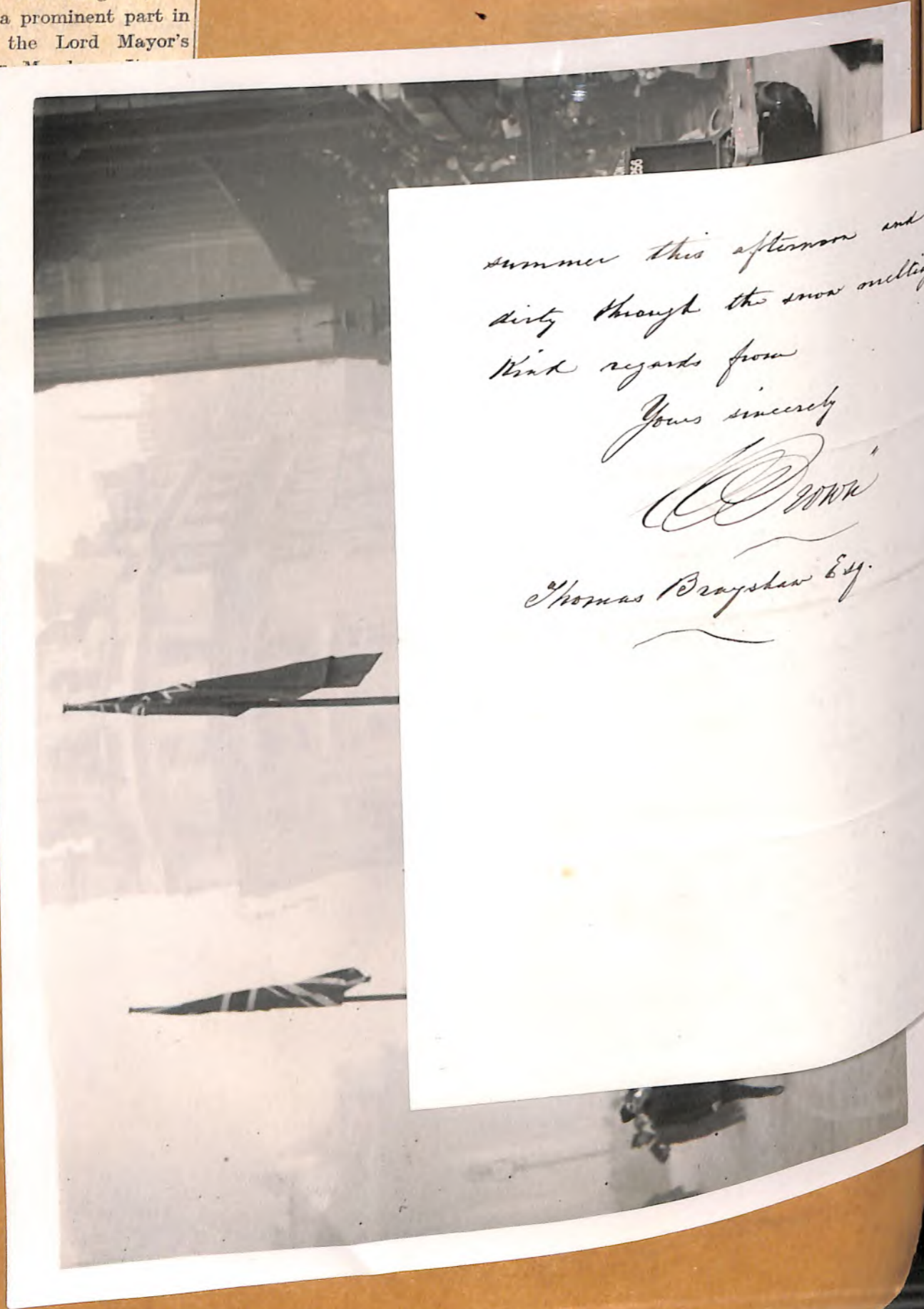



The Honorary Secretary begs to express his sincere thanks for the very liberal support he has again received from all classes, which enables him to have the honour, for the 18th time, to announce an increase in the Annual Subscriptions.

A summary of the services rendered by the Lifeboats of the National Institution during the year 1880 shows a total of 577 lives and 27 vessels saved from destruction. In the same period the Lifeboat Institution granted rewards for saving 120 lives by fishing and other boats and means, making a total of 697 saved last year through its instrumentality. Altogether, since its formation, the Society has contributed to the saving of 27,000 shipwrecked persons.

It should be mentioned that the operations of the National Lifeboat Institution now cover the whole coasts of the British Isles, and that all the Lifeboats of the United Kingdom belong to it, with the exception of a score or so of Lifeboats which are under the charge of harbour trustees and other local bodies.

The Honorary Secretary deplors the loss of four Annual Subscribers, but hopes the subscriptions will be continued by those left to mourn their loss.

As the cost of keeping a Lifeboat station in a state of efficiency is from £70 to £80 per annum, the Honorary Secretary appeals to the general public for further assistance, particularly to those who have never contributed to the noble cause, and has the pleasure to announce that he has already (Jan. 8th), received £38 14s. 0d. in Annual Subscriptions for 1881.
