Imprimis I committ and commend my soule into the hands of Almighty God my maker, hoping for the meritt, and by the mediation of God my Saviour and Redeemer to bee a partaker of life everlasting And my Body to the earth whence it was taken to be buried in the Church yard att Horton in such decent and Christianlike manner, as to my executrix and Feoffes in trust hereafter mentioned shall be thought meete and Convenient, And as for my temporall estate I doe order and dispose of as followeth. Whereas I the said John Tunstall did by Deed formerly passe All that my Messuage lands and premisses, with all and every of their appurtenances lying att Newland houses (called by the name of Newland house) to and for severall uses therein mentioned Yet neverthelesse therein and thereby did reserve unto myselfe full power and authority to charge the said premisses by my last will and Testament or otherwayes with the summe of Eighty pounds of Lawfull English money by mee to be disposed of, as by the said Deed relation being thereunto had, may and doth more fully appeare and whereas I the said John Tunstall did alsoe by another Deed formerly made passe All those my houses lands and premisses with all and every of their appurtenances lying att Horton aforesaid to and for severall uses therein alsoe mentioned, Yet Neverthelesse therein and thereby did reserve unto my selfe full power and authority to charge the said premisses by my last will and Testament or otherwayes with the summe of Forty pounds of lawfull English money, by me to be disposed of as by the said Deed relation being thereunto had may and doth more fully appeare; It is my will and mind and I publish it soe to be that all those several debts which I owe and am indebted to the severall persons hereafter named, for the payment whereof my Kinsman Lawrence Tunstall is and stands bound with mee for the same shall be first paid and discharged out of the one hundred and Twenty pound soe referred unto mee as aforesaid, That is to say to John Taylor of the Topp with interest already due Tenn pounds: To Edmund Litton Tenn pound with interest alsoe already due; To Mary Smith Tenn pound with interest already due: To Mr. Thomas Wilson six pounds with interest already due And to John Armitsted of Horton Batchelor Twenty pound already due & interest for two yeares

And it is my will and mind & I publish it soe to bee That all other debts which I rightly owe and am indebted to any other person or persons whatsoever and not named formerly herein shall alsoe be well and truly satisfied and paid out of the one hundred and Twenty pounds soe reserved to mee as aforesaid and for the better secureing the payment of all and every my debts as aforesaid And for raising some small portions for my two younger Children John and Bryan I doe hereby give and device All and every my said Messuages Lands and premisses unto my trust and well beloved Friends Lawrence Tunstall of Dubcoate in the parish of Horton in Riblesdale & County of York aforesaid Yeoman And Lawrence Lupton of Studfold in the parish & County aforesaid Husbandman, And to the survivor of them & his heires whom I doe hereby impower and authorise my until (by sale thereof or any part or parcell thereof, or by leaseing the same or otherwise as they shall thinke fitt) my said Trustees have raised the said summe of one hundred and Twenty

pounds for payment of my said debts & two younger Childrens portions as aforesaid, And after payment of all my just debts as aforesaid then my will and mind is that the residue of the said one hundred & Twenty pounds bee equally devided by my said Trustees betwixt my said younger Children John and Bryan and after the said summe of one hundred and Twenty pounds bee raised and paid by my said Trustees as as aforesaid then I give and device all the residue and remainder of my said Lands & premisses according to the severall grants & uses mentioned in the said recited deeds and conveyances.
