A Memorial of Indentures of Lease Release and Assignment bearing date respectively the twenty eighth and twenty Ninth Days of February in the year of our Lord Christ one thousand eight hundred and four the Lease being made or mentioned to be made Between Robert Salmon of Hollingburn in the County of Kent Esq<sup>r</sup>. and Ann his wife of the one part and Henry Salmon of Settle in the parish of Giggleswick in the County of York paper Maker of the other part and the Release and Assignment made or mentioned to be made Between the said Rob<sup>t</sup>. Salmon and Ann his wife of the first part John Chrisple of Suttle valance in the County of Kent Yeoman of the second part the said Henry Salmon of the third part and Giles Redmayne of Settle aforesaid Merchant of the fourth part of and concerning All that the Scite of all that water Corn Mill now rebuilt and converted into a paper Mill situate standing and being within the Township of Langcliffe in the Parish of Giggleswick aforesaid called and usually known by the Name of Langcliffe Old Mill Together with the Mill Millhouse (R)ayhouse Storehouse and all and singular other the Edifices and Buildings erected and built thereon with their and every of their Appurtenances and also all those two pieces or Parcels of Land whereon the said Water Corn Mill formerly Stood and whereon the said new erected Edifices and Buildings now stand commonly called the Mill Hill and the Mill Isles containing by Estimation one acre and an half be the same more or Less with the Fishery thereunto belonging heretofore in the tenure or occupation of *blank* Carr ..... of Benjamin Ferrand and now or late of the said Henry Salmon his Assigns or undertenants and all and all manner of Outhouses Edifices Buildings and all and Singular the Suits Tolls Customs Services Mulcture Ways Paths Passages Ponds Waters Watercourses Mill Dams Attachment \of/ Dams Clowes Goites and Steams of Water Flood Gates Flood Hatches Ditches Banks Fences Trees Wastes Waste Grounds Rights Liberties Profits Priviledges Advantages Hereditaments and Appurtenances whatsoever to the said Mill and premises belonging or in any wise Appertaining The execution of which said Indentures of Lease and Release by the said Robert Salmon and Ann his Wife are witnessed by Elizabeth Salmon and Mary Salmon of Holling Bourne aforesaid Spinsters the Execution of the said Indenture of Release by the said John Crispe is witnessed by Mary Crispe and John Crispe the younger of Sutton valance aforesaid and the Execution of the said Indenture of Lease and Release by the said Henry Salmon is Witnessed by John Hartley of Settle aforesaid Gentleman and Cuthbert Singleton his Clerk
